Uzbekistan Visa Requirements

To travel to Uzbekistan you will have to get a visa unless you are a citizen of a “visa free regime” country.

A VISA-FREE REGIME

A visa-free regime is valid for citizens of 55 countries listed below. This exemption is only for short-term visits and the length of time that those citizens can stay in Uzbekistan is limited.

***Citizens with resident status of United Arab Emirates** - a visa-free regime for entering Uzbekistan up to 30 days introduced for citizens of foreign countries who have resident status of the United Arab Emirates (foreign citizens must submit the UAE original resident visa, the validity of which is at least 90 days at the time of entry to Uzbekistan).
